Once again there was a discussion how school districts are going to bigger Divisional Meets, as opposed to Dual Meets in the Spring, which is a reason that we will not be getting as many assignments during Spring season.

Fees for the Spring are: 2 Teams \$80 - 3 carded Officials

3 Teams \$92 - 4 carded Officials

4 Teams \$115 - 5 carded Officials

With the amount of carded officials available, coaches need to make sure there is enough help, so that the meets can run smoothly.

We are in need of starters, schools do not want to reimburse for shells, Jay is trying to get them to give starters a little more money to cover some of the cost.

Make sure you go in early and put in any blocks for days that you know you will not be able to work in the upcoming season. It's very difficult once assignments are arranged to have to go back in and change things.

Make sure you check in, check out with the Meet Referee at each meet. Do not just leave when you finish your assignment.
