Treasurer's Report - Janet Laing - We will be keeping Chapter Dues at \$55.00, due at the end of January. Inactive members will pay \$25. There has not been much activity with the account during the summer, bought some patches at a cost of \$400, paid the insurance bill:

Account Balance \$7,034.76, copies available for anyone to view. Stephen Labreque questioned why we have to pay \$55, when we seem to have a surplus. Janet gave explanation of all expenses, including the proposed budget expenses.

Barbara Banks reiterated that since we ran into the money problem a few years back, it is important that we carry a balance of at least 2 yrs.expenses. Our proposed budget right now is \$5700, which would leave us a surplus of only about \$1500.

Check your Arbiter profile to make sure you have a badge, the badge tells the assignors you are eligible to be assigned. All officials need to take the concussion course as of June, email Lynn Hallenbeck a copy of your completed course.

John McGillvary - another cadet class starting in October at Holmdel High School, 8 week course covering rules and why we have them. When cadets pass the course, they will do shadowing during the Winter season to learn hands on working various events. If anyone knows anyone who may be interested, contact John, just let them know there are physical requirements to this job.
